## SPECIAL SESSION

OCTOBER 6, 2021 FRANKLIN, LOUISIANA

The St. Mary Parish Council held a Special Meeting on this date with Chairman Dean S. Adams presiding and the following members present: Rev. Craig Mathews, J. Ina, Rodney Olander, Leslie Rulf, Jr., Patrick Hebert, James Bennett, Jr., Mark Duhon, Kristi Prejeant Rink, MD, and Gwendolyn Hidalgo. Absent was Scott Ramsey.

The Invocation was pronounced by Mr. Bennett and Pledge of Allegiance was led by Mr. Duhon.

Mr. Adams gave condolences to the families of Larry Frank and Donna Meyer.

Mr. Adams asked if any applicants would prefer to be interviewed in public.

Being none, Rev. Mathews moved that the Parish Council go into Executive Session to interview and discuss qualifications of applicants interested in being appointed to the position of St. Mary Parish Registrar of Voters which reads:

A public body may hold an executive session pursuant to R.S. 42:16 for one or more of the following reasons:

(1) Discussion of the character, professional competence, or physical or mental health of a person, provided that such person is notified in writing at least twenty-four hours before the meeting and that such person may require that such discussion be held at an open meeting.
